The Company confirms that, in the period since re-listing on the ASX, it has incurred expenditures largely in line with the Use of Funds set out on page 113 of its Prospectus dated 3 August 2020. Due to restrictions imposed as a result of the COVID-19 pandemic, it is likely that certain exploration activities will be delayed, reducing the rate at which funds are expected to be spent in the short term.
