360 Capital Group (ASX:TGP) is pleased to announce that it has entered into an agreement to sell its 50% interest in 360 Capital Digital Management Pty Limited (**Company**) to entities associated with its JV partner, David Yuile (the **Sale Agreement**). Under the Sale Agreement, settlement is expected to occur by mid-December 2021. The Company is the Investment Manager to Global Data Centre Group (ASX: GDC).

360 Capital FM Limited will remain the Responsible Entity of GDC until consents under change of control provisions on certain assets are received, at which time it proposes to call a securityholders meeting of GDC to consider the retirement of 360 Capital FM Limited as the Responsible Entity and the appointment of a new Responsible Entity.

Following the change of Responsible Entity of GDC, the Group would have exited all its interests in Digital Infrastructure.

Tony Pitt, Managing Director of 360 capital said, "The joint venture with David has been great and thank him for providing the Group and its investors with access to this exciting asset class. The sale to David ensures the continuity of management and we wish David and the GDC team all the best in continuing to be a successful venture".
