### **Issue of Shares on Conversion of Notes**

Vectus Biosystems Limited (ASX:VBS) (Vectus or the Company) advises that it has issued a total of 162,523 fully paid ordinary shares, being 150,000 fully paid ordinary shares to a note holder following the conversion of 150,000 convertible notes, at a conversion price of \$0.50 per note, plus interest paid in shares. In relation to the accumulated interest on these notes, at an interest rate of 6% per annum and as provided for in the Convertible Note Deed, the note holder has elected to have the interest paid as 12,523 fully paid ordinary shares calculated at \$1.05 per share. Attached is a Cleansing Notice and an Appendix 2A for the above share issue.

### **Appointment of Leading Advisor in China**

Vectus is pleased to announce that Shanghai Jadesen Management Co., Ltd (Shanghai Jadesen) is to provide professional advisory services in relation to potential licencing discussions for its VB4-A32 antifibrotic proprietary drug candidate in the People's Republic of China (China). Shanghai Jadesen is a well-known licenced financial advisory body in China. The role of Shanghai Jadesen will be to represent Vectus in discussions with certain well-recognised pharmaceutical companies in China with regard to the Company's antifibrotic VB4-A32, whose primary indication is the treatment of hepatic fibrosis resulting from all forms of liver disease.

China represents an emerging market for new therapeutic agents, particularly those addressing major unmet needs such as liver fibrosis. Up to 40% of the population is at risk of hepatic fibrosis, with resultant liver failure or liver cancer as a consequence of endemic hepatitis B and C. New agents, such as VB4-A32, may provide a transformational capability addressing first-in-class antifibrotic therapeutics in China.

Vectus' Chairman, Dr Ronald Shnier, said: "We look forward to working with Shanghai Jadesen, which has an impressive record in advising companies on successful transactions in China. It is well positioned to provide ongoing support to the Company in regard to licencing, conducting clinical trials, regulatory approvals, and marketing and commercialising VB4-A32 in China should one or more licences proceed."
