EMVision Medical Devices Limited (ASX:EMV) ("EMVision" or the "Company"), a medical device company focused on the development and commercialisation of portable medical imaging technology, is pleased to report that preliminary images from EMVision's portable brain scanner have been peer-reviewed and published in *Frontiers in Neurology*. *Frontiers in Neurology* is a leading journal in its field, publishing rigorously peer-reviewed articles across a wide spectrum of basic, translational, and clinical research that help improve patient care.

The manuscript titled 'Preliminary images from an Electromagnetic Portable Brain Scanner for Diagnosis and Monitoring of Acute Stroke' notes that due to speed of imaging, size and mobility of the device and negligible environmental risks, EMVision's electromagnetic scanning is a promising additional modality for mobile and bedside neuroimaging.

Dr Weinberger has over 25-years' experience developing and commercialising medical devices.
