Kalgoorlie Mining Company (ASX: KMC) is pleased to announce that it has expanded its search for gold by substantially increasing its tenement holding around the Company's core area of operation – the Bullant Gold Project. The company has expanded its 100% owned tenement area from 12.08sqkm to 27.59sqkm following the granting of exploration tenements by the Department of Mines and Petroleum (DMP). They include 9 Prospecting Licences number P16/2694 to P16/2701 and P16/2689 an area covering 15.51sqkm (see Figure 1 over page).

"The increase emphasises the main aim of the company strategy, to be proactive in acquiring and increasing its land holding in the Kalgoorlie region and to be actively committed to exploration and building its resource base for the Company. The Company has set itself a target of 1M oz's Au contained within its tenement portfolio"

"The next undertaking is to carry out detailed geological investigation of the entire Company tenement package to look for and increase exploration targets. Preliminary investigation shows limited historical exploration work has been carried out on the tenements".
