Dulles Greenway Lodges Federal Court Dispute

Atlas Arteria (**ASX:ALX**) notes that Toll Road Investors Partnership II, L.P (**TRIP II¹**), has filed a federal complaint in the Eastern District of Virginia alleging numerous violations of the Virginia and United States constitutions by the Commonwealth of Virginia, the State Corporation Commission (**SCC**), and the SCC Commissioners in their official capacities, all of whom are named defendants in the action. The complaint alleges the constitutional violations arise from the taking of private property for public use without just compensation, among other things. Through this action, TRIP II seeks compensatory, declarative, injunctive, punitive, and other relief.

This action is distinct from the previously reported TRIP II appeal of the SCC's 2024 rate case order, which remains pending in the Virginia Supreme Court.

Adjacent to the APRR business is the smaller ADELAC business which connects to APRR in south-east France. Together APRR and ADELAC comprise a 2,424km motorway network located in the East and South East of France. In the US, we own a 66.67% interest in the Chicago Skyway, a 12.5km toll road in Chicago and have 100% of the economic interest in the Dulles Greenway, a 22km toll road in the Commonwealth of Virginia. In Germany, we own 100% of the Warnow Tunnel in the north-east city of Rostock.
