

## Battery Age Minerals Receives Maximum Allocation of C\$200k under OJEP for 2024-2025

### **BM8 accepted into Ontario Junior Explorers Program (OJEP) and granted access to additional funding for exploration purposes**

Battery Age Minerals Ltd (ASX: BM8; “**Battery Age**” or “the **Company**”) is pleased to announce that it has been accepted to participate in the 2024-2025 Ontario Junior Explorers Program (**OJEP**). The program, supported by the Ontario government, aims to foster early exploration efforts and provide funding opportunities for junior mining companies like Battery Age.

The Ontario Junior Exploration Program (OJEP) is an initiative of the Ontario government that aims to attract investment in early exploration, expand the pipeline of mineral development projects, including critical minerals, and lead to more mines and jobs in Ontario, Canada.

Under the OJEP, eligible expenses incurred up to a capped threshold, between April 1, 2024, and February 28, 2025, directly associated with and essential to the completion of the project, will be eligible for up to \$200k CAD. Battery Age is thrilled to have been granted the maximum allocation and the opportunity to leverage this financial support to advance its exploration activities.
