Draft Legislation for Temporary Supplemental Tax on Large French Companies

Atlas Arteria (**ASX:ALX**) notes that the French Government has presented the draft Finance Bill for 2025 (the **Budget Bill**). This follows initial reports in the media from September 2024 onwards speculating on the potential for increased temporary taxes on large companies in France.

The Budget Bill proposes a temporary supplemental tax commencing in 2024 concerning companies with revenue greater than €1 billion. If enacted as proposed, the temporary supplemental tax would be as follows:

- 20.6% of the income tax due for the fiscal year 2024 (giving an all-in tax rate of 30.15%¹) and 10.3% of the income tax due for the fiscal year 2025 (giving an all-in tax rate of 27.58%¹) for companies with revenue equal to or exceeding €1 billion² but less than €3 billion.
- 41.2% of the income tax due for the fiscal year 2024 (giving an all-in tax rate of 35.30%¹) and 20.6% of the income tax due for fiscal year 2025 (giving an all-in tax rate of 30.15%¹) for companies with revenue equal to or exceeding €3 billion².

The Budget Bill will be debated in the French Parliament over the coming months. Atlas Arteria notes that the outcome of the debate is uncertain in the absence of a majority at the French Parliament. An outcome of the debate is expected by December.

Atlas Arteria will provide a further update when the Budget Bill is finalised and legislation is passed by the French Parliament.
