SECOND REVISED 2005 AEJ INTERDEALER MASTER EQUITY DERIVATIVES CONFIRMATION AGREEMENT

This Second Revised 2005 Asia Excluding Japan ("AEJ") Interdealer Master Equity Derivatives Confirmation Agreement (this "Master Confirmation Agreement") is dated as of 1 September 2016 between JPMORGAN CHASE BANK, N.A. ("Party A" or "JPMorgan") and National Australia Bank Limited ("Party B" or "Counterparty").

The parties wish to facilitate the process of entering into and confirming Equity Derivative Transactions and accordingly agree as follows:

- 1. Equity Derivatives Definitions. This Master Confirmation Agreement hereby incorporates by reference the 2002 ISDA® Equity Derivatives Definitions as published by the International Swaps and Derivatives Association, Inc. (the "Equity Definitions"). Any capitalized term not otherwise defined herein shall have the meaning assigned to such term in the Equity Definitions.
- Confirmation Process. The parties intend to enter into separate equity derivative transactions (each a "Transaction") set out in a Transaction Supplement substantially in the form attached to an Annex specified in Exhibit I hereto (each, a "Transaction Supplement"). The confirmation applicable to each Transaction, which shall constitute a "Confirmation" for the purposes of, and will supplement, form a part of, and be subject to, the ISDA Master Agreement between Party A and Party B dated as of 5th December 2012, as amended and supplemented from time to time (the "Master Agreement"), shall consist of this Master Confirmation Agreement including the relevant form of General Terms Confirmation contained in an Annex specified in Exhibit I hereto (each, a "General Terms Confirmation"), as supplemented by the trade details applicable to such Transaction as set forth in the Transaction Supplement for that Transaction. In the event of any inconsistency between this Master Confirmation Agreement and a General Terms Confirmation, the General Terms Confirmation shall govern for the purpose of the Transactions related to such General Terms Confirmation.
