Australian Primary Hemp Limited (formerly Alchemia Limited) (ASX: APH) – Reinstatement to Official Quotation

Description

The suspension of trading in the securities of Australian Primary Hemp Limited (the "Company") will lift and the Company reinstated to official quotation at the commencement of trading on Friday, 18 October 2019 at 10:00 am AEDT, following its re-compliance with Chapters 1 and 2 of the ASX Listing Rules. The Company raised \$5,700,000 pursuant to the offer under its replacement prospectus dated 16 September 2019 ("Prospectus") by the issue of 28,500,000 at an issue price of \$0.20 per share.
