RESULTS OF ANNUAL GENERAL MEETING

The following information regarding the results of the Annual General Meeting of Norwood Systems Limited held on 30 November 2020 is provided in accordance with Listing Rule 3.13.2 and section 251AA(2) of the Corporations Act.

It is advised that all resolutions put to the meeting were carried via a poll.

Resolutions 3 and 6 were withdrawn prior to the meeting due to shareholder feedback in respect of concerns regarding dilution, the vesting milestones associated with the LTI's, and proxy results received prior to the meeting.

Since more than 25% of the votes cast for Resolution 1 were against the adoption of the Company's Remuneration Report, this constitutes a first strike for the purposes of the Corporations Act.

The detailed voting results are attached in accordance with section 251AA(2) of the Corporations Act 2001.
