

QUARTERLY REPORT TO 30 September 2014

PROJECT UPDATES - Groote Eylandt Project

During the quarter terms of surrender and final payment for the surrenders of the tenements was reached with the Northern Territory Government. NTM received the sum of \$2.8 million for the surrender of Exploration Licences A27605, EL27523, EL27550 and EL27551 on the 15 August 2014.

NTM still retains the rights to two (2) Island applications currently in Veto within the project area.

Blue Mud Bay

NTM is reviewing our holdings in BMB following the surrender of our Groote Project Tenure. We currently have four (4) Island applications entered into the consent process of the Aboriginal Land Rights Act (ALRA) and these are not affected by the Moratorium.

We also hold the rights to three (3) Exploration Licence applications over the waters of BMB which are affected by the Moratorium which is due to expire in March 2015.

Offshore Commonwealth Waters Project

No action has occurred on these tenements whilst the Northern Territory Government dealt with the Groote Eylandt Project and their self-imposed Moratorium over territory waters.

NTM has recently received communication from the NT Minister for Mines advising that they have referred our applications to the Joint Authority under Section 62 (2) of the Offshore Mineral Act 1994 for consideration in seeking information from the Commonwealth Department responsible for the Environment and Marine Reserves.

The Minister further advised that "As soon as the Joint Authority has received the requested information, a decision will be made on the nine applications."

The Company is awaiting that reply and will advise the market as further information comes to hand.
